Subject: Cruelty, torture and demanding of dowry from me by my husband and in-laws.

Respected Sir,

This is to bring to your kind notice that I, Puja Sarkar, daughter of Partha sarkar and Shipra Sarkar, resident of Dhoop company lane, flat 3B, Shiv Vatika, Pradhan Nagar, Siliguri was married to Tamal Das, son of Late Bijoy Das and Smt. Maya Das, resident of 'Maya Bhawan', Sukanta Pally near Sishu Malancha School, P.O.- Gate Bazar, P.S.- N.J.P. Dist.- Jalpaiguri, Pin-734005, on 23rd Nov, 2019 . At time of the marriage my husband and in-laws had demanded cash and various items as dowry. My parents and brother gave their best of efforts to fulfill the demand of my husband and in-laws and they have managed to give my husband and in-laws 2 Lakh in Cash, sufficient gold ornaments, wooden cot, almirah, dressing table, several utensils and various valuable gifts.

Soon after the marriage my husband and in-laws started to create pressure on me to bring more dowry from my paternal house but I told them that my parents and brother have spent their all savings in connection of my marriage and it is not possible for my parents and brother to spent any further money on the account of dowry. My Husband viz. Tamal Das, my Mother-in-law viz. Maya Das, my sister-in-laws viz. Manisha Sarkar, Mithu Sarkar and Minu Gupta all started immense torture upon me and they used to tell that if I am not able to bring more cash from my parents and brother then they will kick me out of their house. I however tried my best to adjust with my husband and in-laws. After 1 year of our marriage I had undergone an operation for ovarian tumor due to which my left ovary was damaged. Since my operation the cruelty of my husband and his sisters viz. Manisha Sarkar, resident of Fulbari Patan Tea Estate, Mithu Sarkar, resident of Gomasta Para Jalpaiguri and Minu Gupta, resident of Sukanla Pally become more furious and fatal as they blamed me for not being able to conceive after our marriage. Even though the doctors assured us that I am able to conceive even after the operation, they have on several occasions threatened to be sent me back home. My husband and his sisters also body shamed me in front of my relatives for my physical structure. They have also tried to subjugate me and asked me to remain silent and obey to whatever they say as I am still not able to bear a child. Since our marriage my husband himself did not want a child for the first year by saying that he required more timed for a baby. After the operation the doctors asked to wait for 6 months before trying to conceive. Therefore it has been only One year since we have tried to get impregnated given my recent operation. But my husband inspite of having knowledge of such doctor's advise forced me for physical relationship just after 1 months of operation.

Puja Das (Sarkar)

My husband share family matters with his sisters but also share our intimate relation and personal matters with them and all of them together tried to prove me a liar, my mother-in law used to lock me up at home when she went outside for any work and did not allow me to go anywhere alone or visit my parents or allow my parents to visit my in laws.

On 05/05/2022, my husband after using both physical and mental cruelty in connivance with my in-laws had demanded more money and forcefully taken all my gold ornaments and valuable items from my possession and thereafter on the same date my husband with the instigation of my mother-in-law and sister-in-laws above named had driven me out of their home and threatened me with dire consequences and also ordered me to bring more dowry from my home or they will not allow me again to enter their house i.e. my matrimonial house.

I thereafter escape from the evil clutches of my husband and in-laws and compelled to take shelter of my parents. My husband frequently threatening me over telephone and also sent me one legal notice with several false and manufactured allegations which have totally false, frivolous and concocted and such notice indicated his malafide and ulterior motive.

Sir, I have no option but to take shelter of law and I am requesting you to take appropriate legal actions against My Husband viz. Tamal Das, my Mother-in-law viz. Maya Das, my sister-in-laws viz. Manisha Sarkar, Mithu Sarkar and Minu Gupta and your good co operation is very much expected in this regards.
