Sir,

In producing herewith one accused person named Hari Kishor (M/34), S/O- Lt.Kapurchand Sah of Siliguri Junction, PO+PS Pradhan Nagar, Dist Darjeeling under arrest along with following articles under proper seizure.

1] 09 (Nine) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 5.4 liters) and marked as "exhibit A"

2] One bottle Himalayan Gold 60 UP Country Spirit taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1".

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Hari Kishor (M/34), S/O- Lt.Kapurchand Sah of Siliguri Junction, PO+PS Pradhan Nagar, Dist Darjeeling to the effect that today on 25.05.2022 at 17:35 hrs received a source information that one person named Hari Kishor (M/34), is selling liquor at his house situated at Siliguri Junction under Pradhan Nagar PS without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with CV/643 Pankaj Gupta and CV/242 Rakesh Mangar had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of the information.

On reaching there and as identified by the source it found that one person was selling and storing liquor at his house. Subsequently, I along with my force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Hari Kishor (M/34), S/O- Lt.Kapurchand Sah of Siliguri Junction, PO+PS Pradhan Nagar, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18:10 hrs to 18.30 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Hari Kishor (M/34), S/O- Lt.Kapurchand Sah of Siliguri Junction, PO+PS Pradhan Nagar, Dist Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
