On interrogation, made in presence of Shri Raj kumar Ghosh, Inspector of Police, Fulbari ICP, Siliguri Police Commissionerate, PSI(AB) Ajay Lama, ASI(AB)/02 Chamatkar Sarkar, C/875 Sujit Paul, C/454 Sudipta Ghosh, C/670 Abhijit Malakar all of SAP 12th Bn. Dabgram, Jalpaiguri, about other details of candidate including educational qualification and Centre of Mains Examination, he showed inability to answer. He voluntarily confessed that he is not Tushar Mandal but his name is Sagar Saha (24 years) of Mothabari District- Malda. He was asked by the candidate Tushar Mandal for personating in lieu of exchange of money. He has studied upto class -VIII(Eight). He also voluntarily disclosed that he participated in PMT/PET examination personating dishonestly as Tushar Mandal in lieu of promise of money. The said Sagar Saha representing /impersonating himself as Tushar Mandal, the original candidate (whose final written test Roll no. 201302038) confessed that he has introduced himself as Tushar Mandal during PMT/PET as well as before the Interview Board, in exchange of money for providing illegal benefits to Tushar Mandal, as noted above.
