I, Uday Chakraborty of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted 04 (Four) arrested accused persons namely (i) Sola Khan (36 yrs) S/O Late Rufu Khan of Matigara Bazar, PS-Matigara, Dist.- Darjeeling (ii) Md Idris Ali (31 yrs) S/O Md Halim of Biswas Colony, PS- Matigara, Dist.-Darjeeling (iii) Ruksana Begam (28 yrs) W/O Md Idris Ali of Biswas Colony, PS- Matigara, Dist.-Darjeeling and (iv) Kalpana Khatoon (35 yrs) W/O Imamul Hoque of Dulupur, Bhatinda Gram, PS- Raiganj, Dist.- Uttar Dinajpur (not verified). In this regard I beg to report that today on 27.05.2022 at about 14.10 hrs I received a specific source input that four persons including two lady are coming at Biswas Colony under PS- Matigara, Dist.- Darjeeling from Bagdogra side by a small vehicle having Registration No WB/74/AB/7809 with huge quantity of Brown Sugar for delivering the same to their designed customers at Biswas Colony. The matter was diarized in General Diary vide Matigara PS GDE No. 1436, Dt- 27.05.2022 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with , ASI Tapan Das, ASI Dhirendra Nath Mandal, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/974 Mintu Sen LC/1251 Yeangkila Bhutia & LC/1286 Anish Chhetri all of Matigara PS, SPC along with a Spl Team of Special Operation Group, Siliguri Policed Commissionerate being headed by SI Rash Bihari Saha, ASI Binod Jha, C/126 Satrughana Sen left for Matigara Bypass More under PS- Matigara along with investigation kit by govt. vehicle to verify the veracity of the information in hand. This refers to Matigara PS GDE No. 1437, Dt- 27.05.2022 and M.C.C No- 1351/22 Dated- 27.05.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Matigara Bypass More under PS- Matigara I contacted two persons namely (i) Reeju Khan' (40) S/O Late Reyaj Khan and (ii) Parimal Sarkar (42 yrs) S/O late Brajen Sarkar both of Tumbajote, Beldangi, PS- Matigara, Dist.-Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses noted above reached at Matigara Bypass More under PS- Matigara at 14.25 hrs and started to Naka checking at Matigara Bypass More under PS Matigara, Dist.- Darjeeling. At about 14.35 hrs we noticed that the above noted vehicle having Registration No WB/74/AB/7809 is coming from Bagdogra side in high speed but we managed to detained the said vehicle at Matigara Bypass More under PS- Matigara, Siliguri Police Commissionerate and found total four persons including driver and two lady inside the vehicle. Thereafter, we disclosed our identity to the detained persons and the information in hand and stated them that they will be searched in person for the purpose. On being asked they disclosed their identity as noted above and admitted that they have illegally possessed brown sugar for selling the same to their designed customers at Biswas Colony under PS- Matigara as per their requirement. It is also found that Sola Khan S/O Late Rufu Khan of Matigara Bazar, PS-Matigara, Dist.- Darjeeling was seating in the driver seat of the said vehicle, Md Idris Ali S/O Md Halim of Biswas Colony, PS-Matigara, Dist.- Darjeeling was seating in the front seat and two above noted lady were seating in the rear seat of the said vehicle. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazette Officer. At this they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the detained persons to search our Police Party as per provisions of law but they denied to search the police party. Accordingly, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Rajen Chhetri, WBPS, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Brown Sugar and requested him to come Matigara By Pass More under PS- Matigara, Siliguri Police Commissionerate to remain present and to supervise the search and seizure.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely (i) Sola Khan (36 yrs) S/O Late Rufu Khan of Matigara Bazar, PS-Matigara, Dist.- Darjeeling (ii) Md Idris Ali (31 yrs) S/O Md Halim of Biswas Colony, PS- Matigara, Dist.- Darjeeling (iii) Ruksana Begam (28 yrs) W/O Md Idris Ali of Biswas Colony, PS- Matigara, Dist.- Darjeeling and (iv) Kalpana Khatoon (35 yrs) W/O Imamul Hoque of Dulupur, Bhatinda Gram, PS- Raiganj, Dist.- Uttar Dinajpur (not verified) are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.
