In producing herewith the arrested accused person namely Supen Hazra (42) S/O- Lt- Gotilal Hazra of Tarijote, under PS- Matigara, Dist. Darjeeling along with the following articles under seizure viz,

1. 16 (sixteen ) bottles of 60' Up Himalyan Gold Country Spirit containing 600 ml in each bottle and marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",


I, ASI Dhirendra Nath Mandal of Matigara Police Station, SPC do hereby lodged this written complaint against the above noted arrested accused person namely Supen Hazra (42) S/O- Lt- Gotilal Hazra of Tarijote under PS- Matigara Dist. Darjeeling to the effect that on 27/05/2022 in course of special mobile duty along with force vide Matigara PS GDE no 1454 Dtd, 27/05/2022 at around 20.15 hrs and as per secret source information I, along with force held raid at Tarijote in the house of above noted accused person who is selling illicit liquors some of his designated customers clandestinely from his house in high rate. But seeing the police party some customers were flee away to run from the house. On interrogation the above noted accused person disclosed that he is the owner of the house and running the business since long for his wrongful gain. Subsequently, the above noted illicit liquor were found in his house. On demand he failed to produce any valid documents/papers or license in support of storing and selling of the said illicit liquor. Accordingly, I seized the above mentioned illicit liquor under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest inform his ground of arrest. The whole process of seizure and labelled was made in between 20.15 hrs to hrs to 21.45 hrs. Total 9.600 ltrs illicit liquors.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted accused namely Supen Hazra (42) S/O- Lt- Gotilal Hazra of Tarijote under PS- Matigara Dist. Darjeeling and arrange for its investigation.


