**SUB: First Information Report**

Sir,

With due respect, I am producing herewith one Accused Namely Sunil Mahato(22 yrs) S/O Rajindar Mahato of Laharpatty ,Gurung Busty, PS-Pradhan nagar Dist- Darjeeling .

I beg to report that today i.e 26.05.2022 I was engaged in night mobile van duty under PS area, with C/704 Ratan Rai, VP /09 Sanjiv Kodolia, vide PDN PS GDE No.1690 dated. 26.05.2022. I was patrolling near Gurung Busty ,Loharpatty Ghat area under Pradhan Nagar PS and found that above noted accused person carrying sand from Loharpatty Ghat river bed with the help of shovel and gamla. Accordingly I told him to stop the carrying but he did not pay any heed to me and tried to fled way from the spot , Somehow we chase him and stop the above noted accused person and apprehended him . On interrogation he disclosed his identity as noted above. I asked to the above noted accused person to produce any document in respect of mining river bed from Loharpatty Ghat, but he failed to produce supporting document regarding said mining river bed .He also stated that he was mining and carrying river bed illegally for wrongful gain ,So I arrested him U/S 41 Cr.P.C and also I seized shovel and gamla.

Therefore, I pray before you that a specific case under proper section of law may kindly be Initiated against the accused person Sunil Mahato(22 yrs) S/O Rajindar Mahato of Laharpatty ,Gurung Busty, PS-Pradhan nagar Dist- Darjeeling and arrange for its investigation.
