l, PSI Newton Biswas, S/O- Nirmal Biswas of New Jalpaiguri Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted one (01) arrested accused person namely Rajesh Roy to the effect that today on 27.05.2022 at about 23.45 hrs I received a specific source input that one person is standing at Bhaktinagar Pipe Line under NJP P.S for committing heinous crime. He used to carry and possess small arms & ammunition with him. Accordingly, I informed the matter to the Officer-in-Charge, New Jalpaiguri Police Station. Subsequently, as per his kind direction myself along with ASI Sajal Das, HG/794 Ranjit Roy, VP /08 Laxman Roy, VP/ 13 Jamirul Islam and CV/ 116 Rohit Kumar Mahato all of NJP PS, SPC all of NJP PS and along with investigation kit left for Bnaktinagar Pipe Line area by govt. vehicle to verify the veracity of the information. This refers New Jalpaiguri PS GDE No. 1352 Dt. 27.05.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Bhaktinagar Pipe Line area at 00.15 hrs and being pointed by my source apprehended the above noted accused person named Rajesh Roy and searched him immediately and found the above noted articles from his conscious and exclusive possession. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Rajesh Roy exclusively & consciously possessed this improvised fire arms and one live ammunition illegally with some ill motives.
