This is to bring your kind notice, that yesterday i.e.26.05.2022 at about 6:00 pm while doing regular patrolling within the Reserve Forest on Balasan river bed (GPS coordinates N 26°45'48'', E 88° 18' 26'') at Tarabari Block under Bamanpokhri Range, I along with duty staffs sighted a truck bearing no. WB 78 D 4728, which was stuck in the Balasan river bed and were some labors engaged to load R.B.M (river bed materials) from Reserve Forest illegally.
