Sub :: F.I.R regarding illegal mining and damaged of JCB machine Bearing no. WB 73 E 9505.

Reverend Sir,

This is to bring your kind notice, that yesterday i.e. 26.05.2022 at about 6:00 pm while doing regular patrolling within the Reserve Forest on Balasan river bed (GPS coordinates N 26°45'48", E 88°18'26") at Tarabari Block under Bamanpokhari Range, I along with duty staffs sighted a truck bearing no. WB 78 D 4728, which was stuck in the Balasan river bed and were some labors engaged to load R.B.M (river bed materials) from Reserve Forest illegally.

Then after, when we approached towards for seizure a truck, all labors managed to fled away, leaving behind a stuck truck bearing no. WB 78 D 4728.

Furher, I hired a JCB machine of Mr. Kedar chettri, Garidhura to lift up a stuck truck. But when were trying to do so, suddenly Mr. Dipu Singha, S/o- Jiten Singha, Add- Bagdogra, Rupsing Jote, Dakshin Bagdogra, Darjeeling. came with approx. 70-80 peoples and started throwing stone to us, and ransacked the above said JCB machine, causing a lot of damage to the JCB machine bearing no. WB 73 E 9505 which was used to lift up a stuck truck at Tarabari Block under Bamanpokhari Range.

So, it is found, that Mr. Dipu Singha, S/o- Jiten Singha, Add- Bagdogra, Rupsing Jote, Dakshin Bagdogra, Darjeeling. and approx. 70-80 miscreants nuisance yesterday i.e. 26.05.2022 the Govt. Officials to discharging our duty peacefully, provoking villagers by that was situation on the field getting deteriorate.

Therefore, I would like to request your good self, to immediately lodge F.I.R, investigate the fact under relevant section of Law and take immediate stringent action to above said miscreants as mentioned above from your kind end at the earliest.

This is for your kind information and taking necessary action.
