Respected Madam,

I, Smt. Sufala Roy, W/o Hirok Roy (Munna), D/o Naba Roy, presently residing at Satyen Bose Road, Opp. Kali Mandir, Shiv Mandir, P.S. Matigara, Dist - Darjeeling, Pin - 734012, draw your kind attention that I got married on 29/08/2011 with Hirok Roy, S/o Biren Roy, permanent resident of Dhupguri, Mill Para, P.S. Goarkata, Dist - Jalpaiguri. After marriage I started conjugal life with my husband in my in laws house. That since after marriage, my husband started abusing me and torturing me without any reasons, not only that my father-in-law namely Biren Roy, mother-in-law namely Pratima Roy and brother-in-law namely Koushik Roy used to assault me physically and mentally and asked me to bring money as dowry although the demand of them had to fulfilled at our marriage by our family members. In spite of happened the above incident, for leading happy conjugal life I used to tolerate and in between one boy child namely Ayush Roy, age 11 years born in our family.

Then after few months I came to know that my husband is involved in the prostitute business and he forced me to join this business, when I denied to join then he used to torture me regularly and when I complained to my in laws, then they did not take any action against their son. Then in the year of 2019 we came to Siliguri and started live in a rented house at Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri. After coming Siliguri my husband did not stop to run the prostitute business and again force me to join the business. Then I bound to lodged a complaint on 20/04/2021 against my husband Hirok Roy to the Bhaktinagar Police Station and the case was registered being Bhaktinagar Police Case No. 403/2021, dated 20/04/2021, under Section 498A IPC, which is pending at District Court Jalpaiguri. After lodging complaint, me and my

husband started separately and I used to start to live at rented house in different places at Siliguri and I used to maintain me and my son by doing job in different shops.

On 02/05/2022 he came to my previous rented house at Shaktigarh, Road No. 6, Ward No. 31 and told to my landlord that I am engaged with prostitute business and tried to manipulate him by saying some false story so that I can evict from my rented house. On 05/05/2022 he came and search me at my working place and when I return to my house from my work then he follow me and trying to kill me by sharp knife but luckily I got safe and came back to my house at any way.

After trying to kill me my husband Hirok Roy on 13th and 14th May, 2022 came at my rented house in midnight in drunken state and kicked to my door of the house badly and also rang the doorbell several times and when I did not response he go away from my house. For the above reason I had to leave my rented house on 15th May 2022 as well as he also came to my working place at Rozy Boutique, Seth Srilal Market, R.G. Complex, Siliguri and told to my shop owner the above stated story so that I can suspend from my job also. On 16th May 2022 I had to leave my job also. Now I live in my present address at Satyen Bose Road, Opp. Kali Mandir, Shiv Mandir, P.S. Matigara, Dist - Darjeeling, Pin - 734012 and join in a shop namely Jyotsna Furniture at Near N.B.U, Neem Tala Kali Mandir, Shiv Mandir, P.S. Matigara, Dist - Darjeeling.

So, it is humbly request you to take strong action against my husband because I feel unsafe from my husband and he can kill me in any time, in any place and also send him behind the iron bar.
