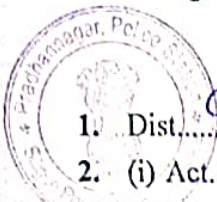

Sir,

In producing herewith one accused person named Kanahia Sharma (35) S/O- Late Santosh Sharma of Tower Chak, Darbhanga P.S- Town P.S, Dist- Darbhanga, Bihar, along with the following seized articles :-

- (1) 160 (one hundred & sixty) Pouch packet of Officers Chioce Deluxe Whisky each packet containing 180 ML. manufacture by allied Blenders and Distillers Pvt. Ltd., Kalyani Industrial growth centre , Phase-III, Plot No- B & G.
- (2) 20(twenty) bottles of Triple eight Blended Whisky each bottle containing 375 ml. manufactured by Blended & bolted by Bengal wine Private Limited, Manahor pur east P.O & P.S. Dankuni coal complex Dist- Hooghly.

I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Kanahia Sharma (35) S/O- Late Santosh Sharma of Tower Chak, Darbhanga P.S- Town P.S, Dist- Darbhanga, Bihar to the effect that on 01/06/2022 at 18:55 hrs. In course of patrolling duty received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his bag in order to sale the same to his design customers for his wrongful gain and who was standing near Champasari Second bridge. Accordingly, the fact is diarized vide Pradhannagar PS GDE NO-49 date 01/06/2022, and informed the fact to you. As per your direction I along with ASI Tarun kanti Ghosh, CV 223 Swapan Chettri and CV-128 Ajoy Sahani left for Champasari second bridge under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the person where he was standing with one bag and detained the above noted person with a strong reason to believe that he has possessed huge quantity of illegal liquor. On searching found (1) 160 (one hundred & sixty) Pouch packet of Officers Choice Delux Whisky each packet containing 180 ML. manufacture by allied Blenders and Distillers Pvt. Ltd., Kalyani Industrial growth centre , Phase-III, Plot No- B & G. (2) 20(twenty) bottles of Triple eight Blended Whisky each bottle containing 375 ml. manufactured by Blended & bolted by Bengal wine Private Limited ,Manahor pur east, P.O & P.S. Dankuni coal complex Dist- Hooghly. On being interrogation, he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 02 months for his wrongful gain. Accordingly, I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19:45 hrs to 20:05 hrs. On being asked he stated that he kept the same with a view to sale and supply at Champasari area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such, I arrested him after observing all sorts' rules for selling the said country made spirit and beer without valid license.

Therefore, I pray before your honour that a specific case may kindly be started against accd. Kanahia Sharma (35) S/O- Late Santosh Sharma of Tower Chak, Darbhanga P.S- Town P.S, Dist- Darbhanga, Bihar as per proper section of law.
