Respected Sir,

With due respect, I, **BINOD PASWAN**, Son of Sri Parameshwar Paswan, Resident of Maharaj Colony , Ward No. 5 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint before your good office to the effect that my mother **Smt. Asha Devi Paswan** is a senior citizen aged about 69 years, suffering with severe old aged ailments. Sir, on 19<sup>th</sup> May, 2022, at about 5 P.m. hours, my mother **Smt. Asha Devi Pawsan**, went to the outside of our house for walking in our locality and during that time, one Scooty vehicle, bearing Registration Number: WB-74-AB-4703, with very high speed and negligent manner, dashed my mother ,making my mother seriously injured and broken leg. Immediately after the said accident, the rider of the said Scooty vehicle tried to fled away from the spot but seeing the said situation, some local peoples gathered there and apprehended the said rider namely **Biswajit** along with Scooty vehicle. Thereafter, one of the local people informed me about the said accident and immediately after knowing the said fact, I rushed to the spot and saw that my mother is seriously injured due to the said accident and when I asked the said rider about the said accident, firstly he started to misbehave with me but after that, he confessed his guilt that due to his negligent driving, the said accident occurred. Thereafter, considering the serious injury of my mother, we brought my mother to nearest Nursing Home at Heritage Hospital, Burdwan Road, Siliguri, where she was admitted and after diagnosing, the attending Doctor informed us that the legs of my mother are severally injured and totally broken and she needs urgent treatment for which, huge amount is required but due to lack of fund,

we could not able to make treatment of mother. Thereafter, on being asked, said rider of the Scooty vehicle, confessed before me that he is not the registered owner of the said vehicle and he is mere employee of his employer namely Sri Debabrata Saha, Son of Late Rai Mohan Saha, Resident of Nehru Road, Khalpara, Siliguri, and one of the Prop. Of M/S Abhoy & Co, and asked me to visit and meet with his employer and assured me that his employer will definitely help us for the treatment of my mother and accordingly, I went to the office of said **Debabrata Saha S/o Lt. Rai mohan Saha** and informed him about the said accident and condition of my mother, occurred due to the rider of the said Scooty vehicle and requested him to provide some financial assistance for the purpose of her immediate treatment and being a meager person, we could not avail such huge amount for her treatment and hearing the same, said **Debabrata Saha** became furious and started to misbehave with me and also used so many filthy and abusive language/slangs by using my Caste by saying that "**Bhikari Sala, Chota Jaat Ka Admi, Tumlogo Ko Sirf Paise Lootne Na Ka Bahana Chahiye.....**" and many more words by using my Caste in public place in presence of the local inhabitants though, he is much very much aware that I belongs to a member of reserved category and in order to harm my religion/caste, he used such type of offensive languages towards me and my family and also asked me to admit my mother in the Govt. Hospital as he is not at all interested about my mother and thereafter, ousted me from his office and also threatened me not to visit at his office in future, otherwise, he will not hesitate to ruin my life and also threatened that he has strong Political and Administrative hold in and around the Siliguri area and nobody will do anything against him. It is also pertinent to mention that on **28/05/2022**, he along with his Nephew **Sri, Rajdeep Saha S/o Sri Khokon Saha** came to our locality, where they have some Business Activities, and on seeing me in the locality , they again started to misbehave with me and also used so many filthy and

abusive language/slangs by using my Caste and many more words by using my Caste in public place in presence of the local inhabitants of my Locality and threatened me with dire consequences ,if I even accidentally appear before them . Sir, due to the poor health condition of my mother, I was busy to arrange funds for the treatment of my mother for which, some delay has been caused for lodging the written complaint and the same may be condoned.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against said **Debabrata Saha, Rajdeep Saha** as per the provision of law and obliged thereby.
