vulgar language against my dignity when I protested the  
said Ram Sahani assaulted me and also told my blows  
and pulled my saree and I cried for help then all  
the family members of Ram Sahani namely Bharat  
Sahani s/o Singesar Sahani, Kamal Sahani s/o Shyam Sahani  
Baiju Sahani s/o Dilip Sahani, Teto Sahani d/o Singesar Sahani
