Sir,

I, the undersigned would like to draw your kind attention to your good concern authority on the matter briefed below:

That Yesterday i.e. on 29.05.2022 at about 10.30 p.m., I along with my friend namely Sri Prasenjit Sen went to have dinner in a restaurant namely 'Spice Garden' situated at Near Gostho Paul Statue, Opposite of Bidhan Road, Siliguri and in the mean time while having dinner, some antisocial miscreants namely, 1. Subham Dutta S/o not known, resident of near Samar Biri Factory (7908594046), (2) Aquib, S/o not known, resident of Dangi Para (8918145418), (3) Manav, S/o not known and resident of not known alongwith some other unknown miscreants came under the influence of alcohol and started doing some acts which was intended to provoke us and also they started violating our personal spaces and also started provoking us by hurling abusive languages. We being responsible citizens did ignore them as much as possible and tried to leave that place of occurrence but that only intrigued them more and they restrained us and the said Subham Dutta suddenly assault me by a bottle of beer with an intention to kill me with very much of subjective knowledge to murder me with empty beer bottles on my head. In the mean time said aaquib with the help of the other miscreants started breaking more bottles of beer on my head and also assault me with fists and blows and injured my eyes. My friend Prasenjit Sen tried to save me but he was also unfortunately attacked by those miscreants.

From the very face of it, it is evident that they under the influence of their self done intoxication tried to kill me. With the help of the hotel stuffs we somehow managed to escape the place of occurrence holding our lives on our hands. It is

pertinent to mention here that the whole incident was captured and recorded in the CCTV footage of the said hotel.

I would like to further inform you that thereafter I was taken to the Siliguri District Hospital by my friend and hotel staffs where my preliminary treatment was done.

Under above mentioned facts and circumstances it is hereby prayed that respected sir kindly take up this complaint and investigate the matter for the ends of justice.
