Sir,

I, Sneha Saha, wife of Dipankar Saha resident of Raja Ram Mohan Road bylane, near Manshamandir Hakimpara, P.S Siliguri District Darjeeling would like to inform you that I was married to Dipankar Saha on 17th January 2000 as per hindu rites and custom . That at the time of marriage my father had given me gold necklace, 4 pair of gold earring, 8 pairs of gold bangles, gold chur, 5 finger rings, silver anklate, silver key ring, furnitures, washing machine, television, brass utensils etc. That after marriage all my streedhan properties was brought in my matrimonial house, I started residing in a joint family with my father in law, my mother in law namely, Anju Saha, brother in law Subhankar Saha and my two sister in laws. That after marriage as per the instruction of my mother in law I had handed over all my jewelleries in her custody. I had a cordial relation with my husband which was not liked by my mother in law, I was made to work like a servant in my matrimonial house however with the hope that everthing will be alright I adjusted. That my mother in law used to tell my sister in law to send their clothes in my matrimonial house from their matrimonial house and i had to wash all those clothes and even press them and send it back. That even my sister in law namely Sushmita Saha and Paromita Saha Ghosh most of the time used to stay in matrimonial house and they also used abusive languages against me. That my brother in law is an drug addict and he used to use abusive languages against me , however I didnot protest thinking with time everything will be alright. In the year 2005 my brother in law was not able to find his wearing apparel on that issue my mother in law started blaming me that I cannot keep things properly, and I am of no use and my brother in law caught hold of my hair and started physically assaulting me, however at that time i did not say anything to my husband thinking it will create bitterness in the family. That on and off my brother in law and my mother in law used to say me that if I had to stay in their family I had to stay according to them. On and Off my brother in law on every petty issues used to blame me and my mother in law always used to support him. That many a times my brother in law also used to fight with my husband as my husband used to protest when he used to have brownsugar in the room and the burning smell of the brown sugar used to cover the room, inspite of protesting against the activities of my brother in law, my mother in law used to blame my husband stating that he was doing the same at the instigation of his wife. That in the year 2014 due to his addiction activities my husband decided to live separate and my mother in law started blaming me for the same. That I and my husband started to stay on the ground floor of the building because of which my mother in law and sister in law on and off started using abusive words against me and my husband. Several times my mother in law used to throw water, garbage in front of our stairs and several times used to switch off the main switch off the house. That on 26/5/2022 I had asked my mother in law to give back my gold jewelleries which was in her custody but she told me that she had sold all my jewelleries and will not be able to return the same and used abusive language against me. That on 29/5/2022 my husband was not there in the house and my brother in law namely Subhankar Saha at 7.30 pm came in an addicted condition on the ground floor of the house and started using abusive language against my husband and also used abusive language against my dignity stating everything belong to them. That when I tried to protest he caught hold of my hairs and physically tortured me with kicks and blows. I cried for help and my mother in law started shouting from upstairs stating that it was me

who had done everything and I am alakhi who had come to their house. That i called my husband over phone, who came and took me to the doctor.

I therefore request you to kindly look into the matter and take action against my mother in law namely, Anju Saha, brother in law Subhankar Saha, sister in law Sushmita Saha and Paromita Saha Ghosh.
