I, Smt. Praswasti Bose wife of Sri. Pinaki
Sarkar resident of "Mohar Kunja Appt; E.V
Pally; Raja Ram Mohan Roy Road; P.O-Rabindra
Sarani; P.S-Bhaktinagar; Dist-Talpaiguri
Siliguri-734006" downloaded an SBI Card
App from the play store. Yesterday at about
4:20 pm, I opened the App and called the
customer service from there and tried to know
about my ₹944 due on the credit card A/c.
But the customer service No. is not showing
in my call log presently. After getting conn-
ected, I enquired about the due amount but
immediately the call was disconnected and
a phone call from the No. 6372619906 came,
where he assured me of resolving my issue.
He asked me my registered mobile No. and
my date of birth, which I provided him.

Then after few minutes messages were received of three unauthorised transactions amounting ₹ 52,000; ₹ 48,000 and ₹ 919.53 made on 01/06/22 at about 4:30 pm - 5:45 pm (approx) from my Credit card A/c No - 4377484894632390 without my knowledge. The details of the messages are being enclosed herewith. Moreover, I blocked my Credit Card No. too after complaining about the incident on the SBI Card toll free No, when the S.R NO ^{given} was - 1163544646941.

Therefore, I request you to kindly take suitable steps in this regard as per law.
