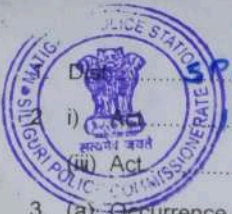

SUB: WRITTEN COMPLAINT

Respected Sir,

I, Neha Tamang, W/O Aakash Tamang aged about 42 years, permanent resident of Pathar Ghata, Khaprail, P.O P.S Matigara Dist Darjeeling would like to bring into your notice that I am married to Shri Aakash Tamang, S/O Lal Bahadur Tamang, R/O Khoplashi, Sainik Puri, Khaprail, P.O & P.S Matigara Dist Darjeeling, on 2<sup>nd</sup> August 2003 and my relationship with my husband was smooth for the few years but my husband started acting in different ways and also used to physically abuse me frequently and would pick up quarrel in pretext, but in order to save my marriage I always used to things thinking it to be the ups and downs of a married life but in the month of October 2021 I went to visit my daughter who is working in Dubai and when I returned back from Dubai, I found my husband behavior totally different from previous one and he started avoiding me and I had a intuition that something is wrong and started inquiring about him whereby I found objectionable messages in his mobile phone from one lady namely Monika Singh and when I further inquired on the matter my husband became furious and started abusing me with fist and blows and since then our martial relationship was not quite working for few days but later my husband approached me and apologize for his behavior and promised me that he shall not meet the said Monika Singh and since then we resumed our marital relationship once again.

That sir,

I am a Christian lady and I am also associated with preaching Christianity and Yesterday dated 31/05/2022 I went to kurseong for a meeting regarding our religion with my friend and while returning back from kurseong I was stunned to see the bike of my husband parked at O (ZERO)Point in a bike and there after I and my friend searched my husband in the surroundings where I spotted my husband kissing the said lady, and after seeing me my husband became furious and grabbed me by my breast and punched me in my stomach but my friend somehow rescued me from the spot and dropped me in my home thereafter during late evening my husband came in our house with the same lady and threatened me that they have filed a false F.I.R against me for attempt to murder and further stated that he is not afraid of me and they both shall get married soon as they have been exposed in front of family and friends he further stated that he shall divorce me and shall drive me off our house and slapped me numerous times and left the house that sir today morning he again called me and stated that if I agree to file mutual divorce then he shall withdraw the false F.I.R and if I do not comply to his demand he shall make my life miserable by filing other false cases against me that sir, I am still in mental trauma thus I hereby request you to take necessary action against my husband and his girlfriend Monika Singh, that sir I am also afraid that my husband and the said lady would visit my home and further commit some crime against me.
