

Sir,

With due respect I, Manju Oraon, D/o Lt. Samir Oraon, a schedule Tribe, of Lichu Bagan, P.O. & P.S. -Matigara, Dist. -Darjeeling, beg to inform you that in the year 2020, I got married with one Md. Saheb, son of Md. Najimuddin, resident of Tari Jote, P.O.-New Rangia, Under P.S.-Matigara and thereafter due to our wedlock one daughter was born.

Soon after our marriage, my husband started treating me like his maid and started calling me with unspeakable names and also used to hit me with fist and blows whenever he is unsatisfied of me and he also used slang languages about my origin. I being a helpless lady tolerated all such physical and mental torture upon me with a hope that one day my husband would come to her senses and stop such torture upon me. Gradually, along with the torture, my husband had also adapted a new tendency of asking me to bring money from my parental house and when I objected to bring the same, he started assaulted me with fist and blows and also kicked me in my belly. Thereafter, my husband assaulted me and had thrown me out of my matrimonial home and told me to bring 2 Laks rupees from my parents or else he will not take me back and as protection he is keeping all my necessary documents which includes voter card, my school document including my class 10 and class 12 certificate, my college documents, my birth certificate, my bank passbook, my child's birth certificate etc. My husband also threatened me that if I try to return to my matrimonial home I shall face dire consequences.

Therefore you are requested to take proper steps against Md. Saheb and oblige me.
