**SUB :-** **FIR AGAINST LAND GRABBERS**

Respected Sir,

1. PI ref FIR lodged on 26 Jun 2020 (copy attached as **Appendix 'A'**)
2. It is intimated that I Mrs Anuradha Syangden, Scheduled Tribe (ST) by caste R/o Naya Bazar, Kurseong, District-Darjling, West Bengal possess a land measuring 0.165 acres in plot No Rs 264 (LR 436) bearing Khatian RS 23/1, LR 228 at Khopalashi, Mauza-21 (copy attached as **Appendix 'B'**).
3. I have bought the said land on 28/11/2007 from Mr Jagru Oraon s/o late Kahu Oraon R/o Simulbari T.E. However, since 2019 the land grabbers are forcibly trying to grab my land and threatening me of life, preventing me from visiting my land, doing any construction work so that dishonestly they can sell it off to other people. Also, they are trying to extort money from me for allowing me to visit my land and using it. In the pursuit to grab my land they have done the following acts of crime :-

- (a) **Forcibly** vandalized my personnel property by using JCB and further tilled it.
- (b) **Threatening of life** on visiting my site of land.
- (c) Dishonestly **induce delivery of property** thereby to sell it off.
- (d) **Criminal breach of trust** by reclaiming the sold property.
- (e) **Extortion.**

4. The under mentioned land grabbers are perpetual defaulters and have records of similar crime in the area :-

- (a) Md Jahid R/o ShantiNagar, Jali Busty, Kaprail.
- (b) Md Toidul (Master), Pachkalguri.
- (c) Krishna Singh R/o Sainikpuri, Block C
- (d) Mala <sup>Chetki</sup> Chhtri w/o Karan Bahadur Chhetri R/o Khaprail.
- (e) Jagru Oraon s/o late Kahu Oraon R/o Simulbari T.E
- (f) Mohan Oraon s/o late Kahu Oraon R/o Simulbari T.E
- (g) Bhinsa Oraon s/o late Kahu Oraon R/o Simulbari T.E
- (h) Smt Muni Oraon, Daughter-in-law of late Kahu Oraon R/o Simulbari T.E.
- (j) Smt Depali Oraon Daughter-in-law of late Kahu Oraon R/o Simulbari T.E
- (k) Other two Daughter-in-law of late Kahu Oraon R/o Simulbari T.E

5. In view of above crime, you are requested to the book the land grabbers under sui IPC for the following crime :-

- (a) Threatening of life.
- (b) Dishonestly inducing delivery of property.
- (c) Criminal breach of trust.
- (d) Abetment to extort money
- (e) Criminal intimidation.
