But today while I was Closing my Said Shop they all forcefully entered in my Shop and started Assaulting me with iron Rods and I sustained grave injuries and seeing all this my younger Brother Rohit Rai & Bablu Mandal S/o Rana Krishna Mandal R/o upper Bagdogra Mandal Para came to my rescue but they were also brutally Assaulted by the Above mentioned people In the Said brutal Attack they also took away ~~and~~ 1,30,000 Rupees in Cash along with my Gold chain. they have also destroyed my Shop and ~~go~~ electronic Items in my Shop and they also took my the I-Phone of my staff namely Bablu Mandal I was so brutally assaulted by them that I became unconscious I have also sustained various deep Cut Mark injuries over my face arms and palm.

But with the help of my family members somehow I took the primary treatment in Bagdogra P.H.C and the reports clearly shows the brutal Assaults over my body and over the body of my brother
