I, ASI Khagen Barman of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one arrested accused person namely Ajoy Singh (38) s/o Lt. Kishan Deb Singh of Chwpukuria PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;


1. Twenty five (25) sealed Bottles of Officers Choice Prestige Whisky, each bottle 750 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1 .
2. Thirteen (13) sealed Bottles of Mc. Dowels No.1 Celebration RUM, each bottle 180 ml each Marked as exhibit -B in which 01 bottle taken as sample for examination exhibit-B1, .
3. Twenty five (25) sealed Bottles of Emboss Fine Whisky, each bottle 375 ml, Marked as exhibit C in which 01 bottle taken as sample marked as Exhibit-C1 .

I am submitting a written complaint against the above noted accused person to the effect that today 02.06.22 at 20-05 hrs received secrete source of information that one person was stocking huge quantity of Liquor and selling the same illegally from his house at Chowpukuria to its customers without any valid license. Accordingly the duty officer of Bagdogra PS noted the information in GD vide Bagdogra PS GDE No. 102 dt. 02.06.22. and informed to O.C. Bagdogra PS and as per instruction at 20-15 hrs myself along with mobile van officer SI Lawang Bomzon and force and CV- 389 Janak Singh, VP- 02 Pradip Roy had been to the spot to verify the veracity of information vide Bagdogra PS GDE No. 103 dt. 02.06.22. On arrival at the spot at 20-45 hrs it was found that one person mention above was selling liquor from his house at Chowpukuria to the customers illegally to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by me, On being asked he disclosed his name and address mentioned above. There after I called two disinterested witnesses from there namely (1) Sujit malpahariya (32) s/o Rupan malpaharia of Chowpukuria PS Bagdogra Dist. Darjeeling and (2) Joynal Abedin (30) s/o Md jaijul of Halal Ps Bagdogra Dist. Darjeeling, in the very presence of the witnesses I searched and recovered the above mentioned liquors from the possession of the apprehended person and seized the same as per proper seizure List and labelled duly signed by him and also witnesses . On being asked the said person failed to produce any document or license for stocking and selling liquor from his shop and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 20-55 hrs and 22-15 hrs (seizure Total 30.4 Lts).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Ajoy Singh (38) s/o Lt. Kishan Deb Singh of Chwpukuria PS Bagdogra Dist. Darjeeling and arrange for its investigation.
