Sir,

In producing herewith One arrested accused persons namely Danial Ali (34) S/O Siddiq Ali of Shantiniketan, Medical, PS- Matigara, Dist.- Darjeeling along with the following articles under seizure as per seizure list:

- i. One Black Color packet wrapped with Transparent Polythene Containing 10.500 kg said to be Ganja and marked as Exhibit "A".
- ii. One packet wrapped in Black Color polythene Containing 10.400 kg said to be Ganja and marked as Exhibit "B".
- iii. One packet wrapped in Black Color Polythene Containing 09.500 kg said to be Ganja and marked as Exhibit "C".
- iv. One Black Color packet wrapped with Transparent Polythene Containing 05.300 kg said to be Ganja and marked as Exhibit "D".
- v. One Blue Color bag with red strip Bag style as Adidas.
- vi. One Black Color bag with blue color strip style as Adidas.

I, SI Padeep Diyali of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on today i.e. 30.05.2022 at 01.15 hrs I received a secret source information that One person would be coming from Matigara side and proceeds towards Jalpaiguri side with huge consignment of Ganja. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, Siliguri Police Commissionerate, and I diarized the fact in General Diary vide New Jalpaiguri PS GDE No 1453 Dated 30.05.2022. Consequently, at 01.25 hrs, myself along with ASI Sajal Das, VP/08 Laxman Roy, CV/116 Rohit Kr. Mahato, HG/794 Ranjit Roy all of New Jalpaiguri PS, Siliguri Police Commissionerate left for Noukaghat More, near Mahananda Bridge to verify the veracity of the information vide GDE No 1454 dated 30.05.2022 & vide MCC No.-1457/22 Dated: 30.05.2022 by Govt. Vehicle taking necessary articles like white paper, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 01:35 hrs we arrived at Noukaghat and parked the vehicle. Meanwhile, I called two independent disinterested witnesses namely i) Sukamal Sen Gupta S/O Lt. Subir Sen Gupta of Shaktigarh, Road No. 03, P.S- NJP, Dist- Jalpaiguri and ii) Buddha Deb Saha S/O Arun Saha of Suryasen Colony, P.S- NJP, Dist.- Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any in which they agreed. Meanwhile, our Police party started looking for accused persons as well as Vehicle and finally at 02.15 hrs we noticed one person carrying two bags in both hand coming from Jalpaiguri Side and proceed towards Matigara Side. Accordingly we apprehended the accused person at Noukaghat, Mahanda Bridge. I disclosed our identity to him. On being asked he disclosed his name and address as noted above I told him about the information in hand but he denied. Finally after prolonged interrogation he admitted that there is Ganja kept in both the Bags carrying by him in his both hand. I, then, gave him option notice in writing that whether they wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. He agreed to be searched in presence of police Gazetted Officer.

dingly, I served the Notice as per provision of law to him which he duly acknowledged receiving and signing in the copy of Notice. Accordingly, I informed Sri Kukil Chandra ACP Investigation, Siliguri Police Commissionerate regarding apprehension of said with huge consignment of said to be Ganja and requested him through messenger to at Noulkaghat, at Mahananda Bridge and remain present as Gazetted Officer during the search and seizure if any which he duly accepted. At 02:55 hrs Sri Kukil Chandra CP Investigation, Siliguri Police Commissionerate arrived at the spot in uniform and ed his identity to the detained person as well as witnesses as a Gazetted Officer, Sri Chandra Roy, ACP Investigation, Siliguri Police Commissionerate. I also offered the edent witnesses and the accused person to search me and our Police Party as per on of law. But he refused to search the police party. Under the supervision Sri Kukil a Roy, ACP Investigation, Siliguri Police Commissionerate and in presence of edent and disinterested public witnesses, I searched the detained person physically g all formalities keeping decency but nothing could be recovered on his person except e apparel. Then, I, in presence of witnesses and under the supervision of Sri Kukil a Roy, ACP Investigation, Siliguri Police Commissionerate searched bag carrying by both hand and found 04 (Four) packets wrapped in Black Color Polythene of said to a Total 35.700 Kg Said to be Ganja which were kept in both the bags carrying by him both hand. On demand, in presence of the Gazetted Officer Sri Kukil Chandra Roy, vestigation, Siliguri Police Commissionerate he failed to produce any valid document ort of possessing/procurement of said to Ganja which were kept inside the two bags.

I, accordingly, seized the said 04 (four) packets wrapped in polythene said to be under proper seizure list and sealed and labelled the entire article in presence of Sri Chandra Roy, ACP Investigation, Siliguri Police Commissionerate and independent eses and accused persons duly signed by the above noted witnesses and the Gazetted Sri Kukil Chandra Roy, ACP Investigation, Siliguri Police Commissionerate and wledged by the accused persons. The labelling and seizure was made between 03:05 03.45 hrs. Then, I arrested the above noted accused person after observing all nes of Apex court of arrest, as they violated the provisions of Narcotic Drugs by ssing said to be Ganja without any valid authority, document or license. On ogation the accused person as noted above, admitted that they procured the said to be a from Coochbehar for the purpose of making money illegally.

Under the above circumstances, I pray to you that a specific case under proper on of law may kindly be started against the accused persons namely Danial Ali (34) S/O iq Ali of Shantiniketan, Medical, PS- Matigara, Dist.- Darjeeling and arrange for its stigation.
