Matigara in the District of Darjeeling – 734010, Director of SILIGURI ENCLAVE PRIVATE LIMITED, having its office at Shop No. 10, 4th Floor, Jeevandeep Building, 4th Mile, Sevoke Road Siliguri District- Darjeeling 734008, would like to lodge a complaint stating as follows:
