Sir,

In producing here with the one arrested accused person namely Bishwanath Das @ Bishwa 37 yrs s/o Nayan Das of c/o Debasish Sarkar of Bokila busty, PS- Matigara Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml.

I ASI Rabin Lama of Siliguri PS under Siliguri Police Commissionerate lodge a written complaint against the arrested person namely Bishwanath Das @ Bishwa 37 yrs s/o Nayan Das of c/o Debasish Sarkar of Bokila busty, PS- Matigara Dist- Darjeeling to the effect that on 03/06/2022 at 18.45 hrs during my PC mobile van duty (vide Siliguri PS GDE no-164 dated 03/06/2022) I received a source information from Ramghat, ward no 05 under Siliguri PS that one person namely Bishwanath Das @ Bishwa he selling huge quantity of liquor illegally under Mahananda bridge near Ramghat, ward no 05 PS- Siliguri Dist- Darjeeling since long, for his wrongful gain. After received the information myself along with ASI Siben Sarkar CV/283 Prosenjit Dey, CV/622 Ramanath Barman proceeded to the P.O to work out the source information, at about 18.55 hrs I along with my police team reached at Ramghat ward no 05 and contacted with the source, on being identified by the source our police team managed to apprehended the said person and recovered Fifteen (15) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, laying on the road side of the dark place. On interrogation he disclosed his identification as Bishwanath Das @ Bishwa 37 yrs s/o Nayan Das c/o Debasish Sarkar of Bokila busty, PS- Matigara Dist- Darjeeling and he admitted that he sell the same to his design customers from since long for his wrongful gain.

On demand he failed to produce any valid documents or licence in r/o said liquor, accordingly I seized the same viz; 1. Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml from the possession of Bishwanath Das @ Bishwa 37 yrs s/o Nayan Das c/o Debasish Sarkar of Bokila busty, PS- Matigara Dist- Darjeeling (**seizure and labelled was made between 19.05 hrs to 19.25 hrs**) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Bishwanath Das @ Bishwa 37 yrs s/o Nayan Das c/o Debasish Sarkar of Bokila busty, PS- Matigara Dist- Darjeeling under proper section of law.
