I Manju Devi Mandal, W/o Late Devanand Mandal, residing of Santoshi Nagar, ward no. 5, near Khatushyam Mandir, PS Siliguri, Dist Darjeeling beg to respectfully say that I am a widow woman doing maid job in other people's house for surviving my life. I have 5 childrens they are adult and married. Today on dated 02/06/2022 almost 6' o clock at evening when I returned home from my job my son Roshan Mandal and his wife Durga Devi Mandal create a dispute for selling my property. When I say that I am alone and you are not giving me house expenses, I am not selling my property they suddenly starting slang languages and starting throwing my all clothes and goods from my room. When I started shouting at that time my daughter-in-law name Durga Devi Mandal hold my hair badly and saying slang languages, my son try to set fire to my house by gas cylinder. Durga Devi Mandal take a scissor and trying to cut my hair but suddenly my ear is cut and after that bleeding began from my ear. My son hit me by a bamboo and I am injured badly my neighbours came and taken me to District hospital. They also beat in my chest also. They threatening me if I came again this home they will kill me. They pressurized me selling my property for my money. I am very poor. When this incident was happened my 3 sons are not present at that time. If people did not come at that time I could have lost my life due to shedding of blood.

So, I

requested to you that please see my problem and take strict action against my son Roshan Mandal and his wife Durga Devi Mandal. I also attached my medical report.

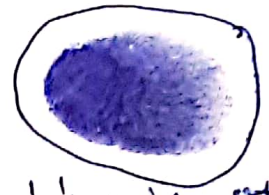
