 with her daughter also use to reside with us but in
 separate mess.

It is painful to mention here that since last
 two months my said daughter in law use to create
 trouble upon me and my husband to gifted certain
 portion and certain portion of our residential house
 and one shop in her name by various foul means and
 ultimately she left our house along with her daughter
 and since then she use to reside in her parental
 house.

It is also to be noted here that my said daughter
 in-law during that period lodged so many cases against
 us and we faced all these cases as per law.

It is to be noted here that on 31.05.2022 my
