Sub: F.I.R. with respect of badly assaulted and tried to kill my younger brother named Lal Bahadur Gurung by Suraj Thakuri @ Kala and his wife of Prakash Nagar, Near Bajrangbali Mandir, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri on 02/06/2022 at night hours.

Respected Sir,

I would beg to inform you that I am residing at Lowe Bhanu Nagar, Ward No.43 of S.M.C, P.O. & P.S. Bhaktinagar, Dist. Jalpaiguri in a rented house of Sri Santosh Kumar since last near about 6 (Six) month and engaged in my Private Job. That since last 2 (two) months my younger brother named Lal Bahadur Gurung also residing with me for searching any job/business.

That on 02/06/2022 at about 9:00 P.M. my brother Lal Bahadur Gurung was found missing from my house. After missing of my brother I have tried to search him every where and also contacted with him into his mobile phone but no any response I had got.

That on 03/06/2022 at about 1:00 P.M noon when I called to him into his mobile phone one unknown person received the said call and introduced him as he is one of the driver and the name of his owner is Pushpa Raj Nirola and his name is Ramesh and he found the mobile phone of my brother from Gandhi Nagar beside the dustbin near Boro Math, Bhaktinagar and told me that he don't know to my brother named Lal Bahadur Gurung.

That on the same day at about 4:00 P.M to the call of Pushpa Raj Nirola, I along with my colleague went to the house of Pushpa Raj Nirola and he handover

the mobile phone of my brother to me and told me that I don't know to your brother Lal Bahadur Gurung and the said mobile phone was getting by my staff on the road and given to me for handover the same to you.

That on the same day in between 5:00 to 6:00 P.M. evening I went to Bhaktinagar for getting enquiry about my missing brother named Lal Bahadur Gurung and I came to know from the police personel on duty of Bhaktinagar Police station that they have recovered to my brother Lal Bahadur Gurung in unconscious conditioned in last night and they admitted my brother at S.D Hospital Siliguri at about 2:50 A.M night.

That thereafter we came to S.D Hospital Siliguri and found that my brother Lal Bahadur Gurung is admitted there on by sustaining multiple injuries into her bodies. Further more my brother told me that on last night said Suresh Thakuri@ Kala @ Ramesh called me at Gandhi Nagar, under P.S. Bhaktinagar and when I went there said Suresh Thakuri along with one women badly beaten & assaulted me with Iron Rod and Bhojali to kill me and also snatched Rs. 10,000/- (Ten Thousand) approximately from my pocket.

Moreover the condition of my brother is serious and the spinal cord and pelvis of my brother is totally broken by the abovenamed culprits with their intention to murder him. At present my brother is admitted in S.D Hospital Siliguri and his treatment is going on.


I therefore request you to kindly enquiry into the matter and take immediate action against the abovenamed culprits who have assaulted my brother badly and tried to kill him, and obliged me.
