Sir,

In producing herewith one accused person namely Ramesh Roy (65), S/O- Late Subal Roy of Baikhantha Pally, Bottle Company W/no. 41 PS Bhaktinagar Dist. Jalpaiguri.

(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 9 Liter & Amount Rs 1800/-).

I SI Pradip Kr Singh of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Ramesh Roy (65), S/O- Late Subal Roy of Baikhantha Pally, Bottle Company W/no. 41 PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 05.06.2022 evening as per order of O/C Ashighar OP I along with ASI Krishna Ch Singha C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 104 Dt 05.06.2022 in course of which I received information from my source that one Ramesh Roy kept some of bottles of liquor inside a bag and selling the said bottles of liquire by turning gouge to the local youth of Baneshwar More in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Baneshwar More area to verify the veracity of information. On the way I called two local person namely (1) Dilip Das (37) S/O Kali Charan Das of Ghogomali PS Bhaktinager Dist Jalpaiguri and (2) ) Sujit Roy (33) S/O Satish Roy of Naresh More Telipara PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Baneshwar More area as indicated by my source I along with my accompanied party surrounded the said Ramesh Roy at Baneshwar More. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched the above noted accused person, in course of which I recovered the above noted bottles of liquor which were kept inside a bag carrying by him. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 18.15 hrs and 18.35 hrs on 05.06.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Ramesh Roy (65), S/O- Late Subal Roy of Baikhantha Pally, Bottle Company W/no. 41 PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
