Sir,

In producing here with the one arrested accused person namely Ajay Giri 33 yrs S/o Abodh Giri of Tikiapara Matangini- 01, ward no 28, PS- Siliguri Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. Seventeen (17) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 17 = 2040/-)

I ASI Siben Sarkar of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Ajay Giri 33 yrs S/o Abodh Giri of Tikiapara Matangini- I ward no 28, PS- Siliguri Dist- Darjeeling to the effect that on 05/06/2022 at about 20.35 hrs during my PC mobile van duty (vide Siliguri PS GDE no-270 dated 05/06/2022) I received a source information from Tikiapara, ward no 28 under Siliguri PS that one person namely Ajay Giri of Tikiapara, Matangini- I he selling huge quantity of liquor illegally at Tikiapara ward no 28 in his hotel to his design customers since long, for his wrongful gain. After received the information myself along with, ASI Rabin lama CV/ Prosenjit Dey, CV/ Ramanath Barman proceeded to the P.O to work out the source information, at about 20.50 hrs I along with my police team reached at Tikiapara Matangini- 01, ward no 28 and, on being identified by the source our police team held raid in the hotel of Ajay Giri and managed to apprehended the said person and recovered Seventeen (17) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which is containing in a white coloured plastic Bag. On interrogation he disclosed his identification as Ajay Giri 33 yrs S/o Abodh Giri of Tikiapara, Matangini - 01 ward no 28, PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers from since long for his wrongful gain.

On demand he failed to produce any valid documents or licence in r/o said liquor, accordingly I seized the same viz; 1. Seventeen (17) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 120 X 17 = 2040/-) from the possession of Ajay Giri 33 yrs S/o Abodh Giri of Tikiapara Matangini- 01, ward no 28, PS- Siliguri Dist- Darjeeling (seizure and labelled was made between 21.05 hrs to 21.30 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Ajay Giri 33 yrs S/o Abodh Giri of Tikiapara Matangini- 01, ward no 28, PS- Siliguri Dist- Darjeeling under proper section of law.
