In producing herewith one arrested person namely Raju Sahani (40/M) S/O Late Bishnu Sahani of Ganganagar, VendiKhet, ward No, 05 PS- Siliguri, Dist- Darjeeling along with 17(seventeen) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ML. & MRP Rs 120/- each bottle Total RS. 2,040/- Only.

I ASI Md. Jinnat Ali of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 05.06.2022 at 19.45 hrs received an information that one person is busy sailing liquors at his House at Ganganagar, VendiKhet, ward No, 05 PS- Siliguri, Dist- Darjeeling for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO – 117 Dated-05.06.2022. As per your kind instruction of O/C Khalpara TOP under Siliguri PS myself along with C/239 Badal Barman , CV/980 Ranjan Ojha and proceeded to the PO to work out the information. At 20:10 hrs. we reached at Ganganagar, VendiKhet, ward No, 05 PS- Siliguri, Dist- Darjeeling some times after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample .The seizure was made in between 20.15 hrs. to 20.40hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Raju Sahani (40/M) S/O Late Bishnu Sahani of Ganganagar, VendiKhet, ward No, 05 PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation .
