- i) That Manoj Choudhury, S/o Lt. Mritunjay Choudhury is my legally married husband.
- ii) That my husband has been torturing me since after my marriage and he even tried to kill me and hit me mercilessly in role to kill me over which case V/s 498 A/307 IPC was stated against him but my husband after the invitation of case convinced me and told to compromise the case. The heaps on instigating me to pick up grassed with him so that he can blame me and he tried to find opportunity to kill me at once he tried to kill me by a sword when I was sleeping and as such I sleep by properly closing my door.
