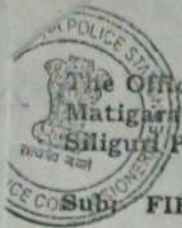

In producing herewith 03 (three) arrested accused persons namely (i) Md Faruk (19 yrs) S/O Abdul Gaffar of Naya Busty, Salbari, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Biswajit Chowdhury (32 yrs) S/O Ramesh Chowdhury of Mothabari, PS- Kaliachak, Dist.- Malda at present residing at Sutki Godwn, Matigara, PS- Matigara, Dist.- Darjeeling and (iii) Dhanesh Barman (24 yrs) S/O Khagen Barman of Colony Para, Matigara, PS-Matigara, Dist. Darjeeling along with the following seized articles under seizure list. The ground of arrest duly been communicated with them.

1. One light green colour sports By-Cycle styled as "POLYTON", Size-M, having Number CE201123 recovered from the possession of accused Md Faruk S/O Abdul Gaffar of Naya Busty, Salbari, PS- Pradhan Nagar, Dist.- Darjeeling.
2. One black colour sports By-Cycle styled as "CROSS BOLT" recovered from the possession of accused Md Faruk S/O Abdul Gaffar of Naya Busty, Salbari, PS- Pradhan Nagar, Dist.- Darjeeling.
3. One black colour sports By-Cycle styled as "DIRT MAX SUNCROSS" recovered from the possession of accused Md Faruk S/O Abdul Gaffar of Naya Busty, Salbari, PS- Pradhan Nagar, Dist.- Darjeeling.
4. One Black Colour By-Cycle styled as "HERO" recovered from the possession of accused Biswajit Chowdhury S/O Ramesh Chowdhury of Mothabari, PS- Kaliachak, Dist.- Malda at present residing at Sutki Godwn, Matigara, PS- Matigara, Dist.- Darjeeling.
5. One black colour sports By-Cycle styled as "HERO SPRINT VOLTAGE" recovered from the possession of accused Dhanesh Barman S/O Khagen Barman of Colony Para, Matigara, PS- Matigara, Dist. Darjeeling.

I, SI Goutam Mallik of Matigara PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused Persons to the effect that on 02.06.22 at 18.45 hrs I received reliable secret source information that one Md Faruk of Naya Busty, Salbari under PS- Pradhan Nagar, Dist.- Darjeeling and his associates storing huge numbers of stolen by-cycle in a abandon room at Paribahan Nagar, Truck Terminus under PS-Matigara, Dist.- Darjeeling. Accordingly, I diarized the matter in General Diary vide Matigara PS GDE No 108 Dated 02.06.22 and informed the fact to you and as per your kind direction myself along with PSI Shekhar Adhikary, ASI Tapan Das, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/974 Mintu Sen all of Matigara PS- Dist.- Darjeeling left for Paribahan Nagar Truck Terminus under PS Matigara, Dist.- Darjeeling to verify the veracity of the information. At 19.15 hrs we arrived at Paribahan Nagar, Truck Terminus under PS-Matigara, Dist.- Darjeeling and being identified by the source we managed to apprehended one person who disclosed his identity as Md Faruk (19 yrs) S/O Abdul Gaffar of Naya Busty, Salbari, PS- Pradhan Nagar, Dist.- Darjeeling. During further interrogation he disclosed that he along with his associates namely (i) Biswajit Chowdhury of Sutki Godwn, Matigara, and (ii) Dhanesh Barman of Colony Para, Matigara, stolen 5 (five) numbers of By-Cycle from different area of Siliguri and kept 03 (three) numbers of stolen By-Cycle in a abandon room at Paribahan Nagar and 01 (One) stolen by-Cycle kept at the house of Biswajit Chowdhury of Sutki Godwn and 01 (One) stolen by-cycle kept at the house of Dhanesh Barman of Colony Para, Matigara. As per his leading statement I held raid in a abandon room at Paribahan Nagar, Truck Terminus and recovered 03 numbers of stolen by-Cycle from his possession. During interrogation he admitted his guilt and on demand he failed to produce any documents in respect of above noted 03 (three) By-Cycle recovered from his possession. Accordingly, I seized the same under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest.


As per his leading statement I held raid at the house of accused Biswajit Chowdhury Sutki Godwn, Matigara, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. being asked he disclosed his identity as Biswajit Chowdhury (32yrs) S/O Ramesh Chowdhury Mothabari, PS- Kaliachak, Dist.- Malda at present residing at Sutki Godwn, Matigara, Matigara, Dist.- Darjeeling and recovered one stolen By-Cycle from his possession. During interrogation he admitted his guilt and on demand he failed to produce any valid documents in respect of the by-cycle recovered from his possession. Accordingly, I seized the same under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. I also held raid at the house of accused Dhanesh Barman (24 yrs) S/O Khagen Barman Colony Para, Matigara, PS-Matigara, Dist. Darjeeling and managed to apprehended him and recovered one stolen by-cycle from his possession. On demand he failed to produce any valid documents in respect of the by-cycle recovered from his possession. Accordingly, I seized the same under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest and brought them at Matigara PS with seized articles. During enquiry it learnt that the above noted arrested three accused persons stolen 05 (five) numbers of By-Cycle from different area of Siliguri and kept the same for its clandestine disposal.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under proper section of law may kindly be registered against the above noted 03 (three) arrested accused persons namely (i) Md Faruk (19 yrs) S/O Abdul Gaffar of Naya Busty, Salbari, PS Pradhan Nagar, Dist.- Darjeeling (ii) Biswajit Chowdhury (32yrs) S/O Ramesh Chowdhury of Mothabari, PS- Kaliachak, Dist.- Malda at present residing at Sutki Godwn, Matigara, PS Matigara, Dist.- Darjeeling and (iii) Dhanesh Barman (24 yrs) S/O Khagen Barman of Colony Para Matigara, PS-Matigara, Dist. Darjeeling and arrange for its investigation.


