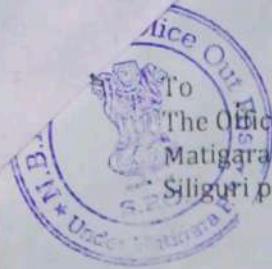

Sir,

In producing herewith arrested accused person named Dilip Barman @ Ujanu (43), S/O - Late Cabal Barman, of - Kawakhali, near Ice Cream Factory, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest, seizure list and seized articles viz 36 (Thirty Six) Sealed Himalayan FATA FATI Bottles 70 Up Country Spirit each containing 300 ML @ Rs. 28/- each totaling amount of Rs. 1008/- marked as exhibit 'A' and one bottle taken as sample.

The fact of the case is that today on 03.06.2022 at 19.25 hrs received source information that one Dilip Barman @ Ujanu (43), S/O - Late Cabal Barman, of - Kawakhali, near Ice Cream Factory, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling have stored huge quantity of ID liquor at his house illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along ASI Dulal Dey, ASI Anupam Roy, C/ 340 Pranab Adhikary, CV-638 Partha Biswas & CV 158 Partha Sarkar left for Kawakhali to work out the information. At about 20.35 hrs held raid at the house of Dilip Barman @ Ujanu (43), S/O - Late Cabal Barman, of - Kawakhali, near Ice Cream Factory, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and on search 36 (Thirty Six) Sealed Himalayan FATA FATI Bottles 70 Up Country Spirit each containing 300 ML @ Rs. 28/- each totaling amount of Rs. 1008/- have been recovered. On demand he could not produce any documents / License for possession such quantity of I.D liquor. On interrogation he admitted that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said 36 (Thirty Six) Sealed Himalayan FATA FATI Bottles 70 Up Country Spirit each containing 300 ML @ Rs. 28/- each totaling amount of Rs. 1008/- in presence of witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C. The search seizure and arrest was made in between 20.35 hrs and 21.05 hrs.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Dilip Barman @ Ujanu (43), S/O - Late Cabal Barman, of - Kawakhali, near Ice Cream Factory, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
