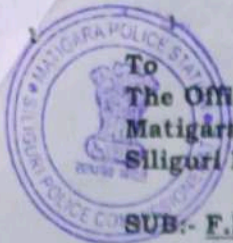

Sir,

In producing herewith one accused person namely Shibnath Sha(20), S/O- Sontosh Sha, of Durganagar, ward No- 04, PS- Siliguri, Dist. Darjeeling along with following articles under proper seizure list :-

(i) 16 (Sixteen) sealed bottles of 'Himalayan Gold 60 UP' Country Spirit each bottle containing 600 ml and each bottle MRP Rs- 120/= Total value Rs. 1,920/- and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1",

I, SI Uday Chakraborty of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Shibnath Sha(20), S/O- Sontosh Sha, of Durganagar, ward No- 04, PS- Siliguri, Dist. Darjeeling to the effect that today on 03.06.22 at 18.05hrs received a source information that one person namely Shibnath Sha is selling liquor in his shop styled as 'Uttarayan Dhaba' situated at Paribahannagar truck terminers under PS- Mtigara, Dist.- Darjeeling without any valid license . Accordingly the fact is diarized in General Diary vide Matigara PS GDE No-213, Dated 03.06.22 and shared the information-with O/C Matigara PS and as per his kind direction myself along with force had been to Paribahannagar truck terminers under PS- Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid in a shop and managed to apprehended the owner of the said shop. On being asked he disclosed his identity as noted above and disclosed that he is the owner of the shop. Further being searched the above noted seized articles were recovered in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Shibnath Sha(20), S/O- Sontosh Sha, of Durganagar, ward No- 04, PS- Siliguri, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18.35 hrs to 19.55hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Shibnath Sha(20), S/O- Sontosh Sha, of Durganagar, ward No- 04, PS- Siliguri, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
