I, Smt. Satarupa Debnath, aged about 30 years, wife of Sri Subhankar Chatterjee, daughter of Paromananda Debnath, presently residing at Block - H, House No.-15, Mallaguri Police Line Housing, P.O.- Pradhannagar, P.S.- Matigara, Dist.- Darjeeling, and working as "Lady Constable", presently posted at Siliguri Police Commissionerate, beg to inform you that on 02nd March, 2017, I got married to one Subhankar Chatterjee, son of Lt. Samir Chatterjee, permanent resident of West Congress Para, P.S.- Kotwali, P.O. and Dist.- Jalpaiguri, according to Hindu rites and customs and after observing all the formalities of Hindu Marriage in presence of parents, all relatives, friends and well-wishers of both the parties.

After my marriage I started our happy conjugal life with my husband. But just after a few days my husband started ill-treating me. I found my husband to be very rude, aggressive and greedy in nature. On 25/03/2019, we got a male child out of the said wedlock. As my mother Smt. Shukla Debnath stays with me at my residence and absolutely depends upon me financially and in all respect as she does not have any source of income and I also maintain her with due respect considering the same as my duty, my husband always looks down upon her and brutally neglects her existence. My Mother-in-law Smt. Sabita Chatterjee always used to provoke my husband to pressurise me to hand over my monthly salary to him. Falsely alleging my ill character in the presence of my family members, my husband used to inflict mental torture upon me even upon my mother. He

always used to threaten me to defame my reputation in public. Even he always used to create pressure upon me to earn more money and even by unlawful means to fulfil his sky high demands and on refusal to that he always used to harass me mercilessly. When he was renovating their dwelling house at Jalpaiguri, without my knowledge, my husband withdrew total amount of One Lakh, using my Debit Card and on protest to that, my Mother-in-law and my husband insulted me with filthy languages. I kept my patience hoping that after few days the mentality of my husband and my Mother-in-law would be changed and everything would be normalised. I always performed all my marital obligations. But all my expectations went in vain. After six months of my son's birth, my husband stopped to reside with me but always kept watching my movements from his sources. He neither took any kind of family responsibility, nor contributed a single penny towards our family expenses. He never disclosed his source of income and on asking he used to make me confused. Since last three months, on several occasions, without giving any prior intimation and in my absence, he took away my minor son from my mother's custody and on asking, he refused completely and used to blame my mother just to harass me and make me puzzled. On protest to the above mentioned incidents, once he threatened me over telephone saying that he would commit suicide consuming poison and put me behind the jail bringing false allegation against me and my mother. My husband is a very cruel type of person and surrounded by many anti-social elements. I am very afraid thinking that any kind of nuisance made by him at my departmental quarter would make me solely responsible. I am also very worried about my minor son thinking that my husband is very much irresponsible and he might injure my minor son just to punish me.

Under these circumstances, I am totally helpless having no clue as to what should I do. So, considering my situation I request you kindly to take necessary and urgent steps as you deem fit.
