Sir,

In producing herewith one accused person namely Nilkanta Barman (19 yrs) S/O Ganesh Barman of Patharghata, Mirjangla, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-

(i) 16 ( Sixteen) sealed bottles of 'Himalayan Gold 60 UP' Country Spirit each bottle containing 600 ml and each bottle MRP Rs- 120/= Total value Rs. 1,920/- and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1",

I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Nilkanta Barman (19 yrs) S/O Ganesh Barman of Patharghata, Mirjangla, PS- Matigara, Dist.- Darjeeling to the effect that today on 05.06.22 at 14.10 hrs received a source information that one person namely Nilkanta Barman of Patharghata, Mirjangla, PS- Matigara, Dist.- Darjeeling is selling liquor in his residence at Patharghata, Mirjangla under PS- Matigara, Dist.- Darjeeling without any valid license . Accordingly the fact is diarized in General Diary vide Matigara PS GDE No 321, Dated 05.06.22 and shared the information with O/C Matigara PS and as per his kind direction myself along with force had been to Patharghata, Mirjangla, under PS- Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of the above noted accused and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Nilkanta Barman (19 yrs) S/O Ganesh Barman of Patharghata, Mirjangla, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 14.55 hrs to 15.35 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Nilkanta Barman (19 yrs) S/O Ganesh Barman of Patharghata, Mirjangla, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
