In producing herewith one accused person namely Gobinda Ray (48yrs) S/o. Lt. Jadab Chandra Ray of Dakshin Saripakuri, PO-Chapadanga, PS-Malbazar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:


1. 12(Twelve) Bottles of 60 Up pet Himalayan Gold Country Sprit each bottle containing 600 ML.

I, SI. Rakesh Debnath of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 03.06.2022 at 15:05hrs received a source information from Farabari, Velkipara that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 94 dated 03.06.22. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/505 Tapash Dutta and (2) C/393 Shyamal Chandra Roy both of Ambari-Falakata OP, Under NJP PS/SPC proceed to Balam Hat to work out the information. At 17:45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Balam Hat and recovered the above noted articles from the possession of accused person namely Gobinda Ray (48yrs) S/o. Lt. Jadab Chandra Ray of Dakshin Saripakuri, PO-Chapadanga, PS-Malbazar, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Pritam Shekher Das S/o. Lt. Goutam Das, of Mohamaya Colony, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Tarjen Ray S/o. Narma Ray of 9 No. Colony, Ambari Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 18:15 hrs to 18:35 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.


I therefore request you that a specific case may kindly be started against the accused person namely Gobinda Ray (48yrs) S/o. Lt. Jadab Chandra Ray of Dakshin Saripakuri, PO-Chapadanga, PS-Malbazar, Dist- Jalpaiguri under proper section of law.
