Sir,

With due respect, I am producing herewith one arrested accused person namely Gasto Mandal (55 yrs) S/O Lt. Sarat Chandra Mandal of Micle Madhusudhan Colony, PS- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 13 (Thirteen) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ML in each bottle.

I, SI Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 03.06.22 at 20.05 hrs I received a secret source information that one person namely Gasto Mandal (55 yrs) S/O Lt. Sarat Chandra Mandal of Micle Madhusudhan Colony, PS- NJP, Dist- Jalpaiguri is selling ID liquor illegally at his house at Micle Madhusudhan Colony under PS- NJP, Dist- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 132 dated 03.06.22 and informed the fact to you. As per your kind direction and instruction myself along with CV-306 Biswaji Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam and others all of NJP PS, SPC left for Micle Madhusudhan Colony, PS- NJP to work out the information in hand. At about 20.25 hrs we arrived at Micle Madhusudhan Colony and being identified by the source I held raid at the house of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.35 hrs 20.50 hrs on 03.06.22

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Gasto Mandal (55 yrs) S/O Lt. Sarat Chandra Mandal of Micle Madhusudhan Colony, PS- NJP, Dist- Jalpaiguri and arrange for its investigation.
