Sir,

In producing herewith one accused person namely Sukru Roy(52yrs) S/O Lt Satish Roy of Ghora more, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Sixteen(16) Pet Bottles of Galaxy Boss 60 up country spirit (each bottle containing 600 ML)

I, ASI. Jamirul Haque of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 05.06.2022 at 17:45hrs received a source information from Sahudangi Bazar, that the above noted person has carrying a huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata out post GDE No-158 dated 05.06.22. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) VP-14 Paritosh Roy (2) CV/01 Jay Chand Roy proceed to Sahudangi Bazar to work out the information. At 17:40 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sahudangi Bazar and recovered the above noted articles from the possession of one accused person namely Sukru Roy(52yrs) S/O Lt Satish Roy of Ghora more more, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Also I seized the above noted articles from the possession of one accused person Sukru Roy(52yrs) S/O Lt Satish Roy after preparing proper seizure list and took signature of the accused person and witnesses namely 1) Pritam Shekher Das S/o. Lt. Gautam Das of Mahamaya Colony PO Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/O Lt NarayanSarkar of 9 no colony PO Kamarvita PS NJP Dist Jalpaiguri. The seizure was made between 20.15hrs to 20.35 hrs and I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Sukru Roy(52yrs) S/O Lt Satish Roy of Ghora more, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri under proper section of law.
