Respected sir,


In producing herewith one seized Shaktiman Truck, bearing Registration No WB 73-7700, I ASI Pradip Singha of NBMC OP under Matigara PS, SPC, Siliguri do hereby lodged a complaint against the Owner and driver of Shaktiman Truck, bearing Registration Plate No WB 73-7700 and others to the effect that today on 06.06.2022 at about 14:05 hrs in course of mobile van duty, I along with C/883 Krishna Ranjan Singha and CV/158 Partha Sarkar reached at Kalamjote Ghat under Matigara PS, Dist- Darjeeling and found some persons were illegally loading sand materials in a Shaktiman Truck bearing plate no. WB 73-7700 from Kalamjote Ghat which is an unlicensed ghat. We tried to apprehend them by seeing the police party, the driver and labours fled away from the spot leaving the partially loaded truck in abandoned condition. The driver of the said truck and others were involved in illegal mining. They were fraudulently taking and carrying the sand materials by violating the Govt. Order for their wrongful gain.

Accordingly I seized the Shaktiman Truck bearing plate no. WB 73-7700 partially loaded with sand materials under proper seizure list in presence and duly signed by the witnesses. The whole process of seizure was made in between 14:25 hrs to 15.05 hrs.

Under the facts and circumstances I pray before you that a specific case may kindly be initiated against the Owner and driver of Shaktiman Truck bearing Registration No WB 73-7700 and others under proper section of law.
