Respected Sir,

I, Biswakarma Roy, Son of Raghubir Roy, resident of Kholachand Fapri, P.O. Sevoke Road, P.S. Bhakti Nagar, Dist- Jalpaiguri, would like to report you the following facts:-

1. That on 04.6.2022 at about 9:30 p.m. when I parked my bike in front of my house at that time my neighbor namely (1) Animesh Barman, Son of not known, (2) Checheli Barman, Wife of Animesh Barman, (3) Subhas Barman, Son of Animesh Barman, (4) Rana Barman, Son of Animesh Barman all are of same locality all of sudden came and caught hold my shirt collar and started abusing me in filthy languages, when I tried to protest them at that time all of them started assaulting me, they brutally assaulting me for 15-20 minutes, I got several bleeding injury on my body, said Animesh Barman and Subhas Barman tried to hit on my head with iron rod with intention to kill me and in this assault I got severe head injury, seeing this my sister in - law namely Tilotma Das Mandal rushed to save me the above named miscreants caught hold her and out raged her modesty and torn her wearing apparel, they also assaulted her brutally, seeing this we both started raising hue and cry, para people gathered and saved us from their clutches. The above mentioned culprits snatched my neck chain made of gold of Rs. 28,000/- and Cash Rs. 3500/-.

I, therefore, request you to kindly take necessary legal action in the aforesaid matter against the aforesaid culprits.
