In producing herewith (05) Five arrested accused persons namely i] Uday Roy(18) s/o Pradip Roy of Barobari Bottle Company, P.S Bhaktinagar, Dist JPG ii) Sambhu Patwari(30) s/o Sushil Patwari of Sashtri Nagar Amtala ,P.S Bhaktinagar, Dist JPG iii) Biswanath @ Bishal Roy (26) s/o Lt Subal Roy of Baneshwar More ,P.S Bhaktinagar, Dist JPG iv) Manoj Roy (27) s/o Iran Singha Roy of Jyotinagar Near Bottle Company, P.S Bhaktinagar, Dist JPG v) Sudhir Barman (23) s/o Subhash Barman of Bholanath More P.S Bhaktinagar Dist JPG and others along with following seized articles viz :-

1. One iron made knife measuring length 36 cm (approx) seized from the possession of accused Uday Roy .
2. One iron rod measuring about 62 cm (approx) seized from the possession of accused Shambhu Patwari
3. One iron rod measuring about 41 cm (approx) seized from the possession of accused Biswanath Roy
4. One iron made knife measuring 26 cm (approx) from the possession of Manoj Roy
5. One iron made Shabol measuring about 65 cm (approx) seized from the possession of accused Sudhir Barman
6. One iron rod measuring about 55 cm (approx) seized from the possession of Manoj Barman

I, SI Binod Singh Rawat of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this suo-moto complaint against the above noted accused persons to the effect that, on 07.06.2022 at about 00:25 Hrs received a source information that some 10 to 12 youths have assembled at Baneshwar more, under Bhaktinagar PS, SPC making preparation to commit crime at that area. Accordingly the information was intimated to I/C Bhaktinagar PS and noted the fact in G.D vide Bhaktinagar PS GDE No-308, Dated 07.06.2022 and as per his direction, myself along with, ASI Deepak Karmakar C 1431 Dilip Barman , CV/614 Sumit Kr Roy , CV014 Labonymay Barman left PS to work out the information. Inform night mobile van officer PSI Sabin Yanzon Tamang and requested him to accompany the raid team. At 00.55 hrs I along with force reached at Baneshwar More under Bhaktinagar P.S and as shown by the source we subsequently cordoned off the place and suspected persons with a strong reason to believe that they were preparing to commit some cognizable offence. Sensing the police had cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 05 (five) accused persons along with seized articles as mentioned above and detained all of them. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the apprehended accused persons admitted that they had assembled there to

commit dacoity at one of the house at Bhaktinagar PS area. They also stated that other persons fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. (The whole seizure was made on 07.06.2022 in between 01.55 hrs to 02.45 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons..

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they stated that they assembled there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons 1 i) Uday Roy(18) s/o Pradip Roy of Barobari Bottle Company, P.S Bhaktinagar, Dist JPG ii) Sambhu Patwari(30) s/o Sushil Patwari of Sashtri Nagar Amtala ,P.S Bhaktinagar, Dist JPG iii) Biswanath @ Bishal Roy (26) s/o Lt Subal Roy of Baneshwar More ,P.S Bhaktinagar, Dist JPG iv) Manoj Roy (27) s/o Iran Singha Roy of Jyotinagar Near Bottle Company, P.S Bhaktinagar, Dist JPG v) Sudhir Barman (23) s/o Subhash Barman of Bholanath More P.S Bhaktinagar Dist JPG and others associates and arrange for its investigation.
