Sir,

I, SI Lawang Bomzon of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one arrested accused person namely Pankaj Choudhury (22) s/o Bipul Choudhury of Barolaska PS Matigara Dist. Darjeeling under arrest along with following seized articles;

1. Twenty one (21) sealed Bottles of Kingfisher strong Premium Bear, each bottle 600 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
2. One Lylon Bag which used to carry the Liquor noted in SL.No. 1.

I am submitting a written complaint against the above noted accused person to the effect that on the night of 03/04-06-22 myself along with force were performed night mobile van duty and 23-35 hrs received secrete source of information that one person was selling Liquor illegally at Bagdogra Bihar More near Bus stand to its customers without any valid license, accordingly I inform the matter to the O.C. PS and duty officer of PS which noted in GD vide Bagdogra PS GDE No. 176 dt. 03.06.22 and as per direction of O.C. at 23-45 hrs myself along with mobile force and CV- 386 Kishor Hawlder CV- 389 Janak Singh, VP- 02 Pradip Roy left for the spot to verify the veracity of information vide Bagdogra PS GDE No. 177 dtd. 03.06.22. On arrival at the spot at 00-05 hrs it was found that one person mention above was selling liquor at Bihar More near Bus stand to his designated customers illegally to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by me, On being asked he disclosed his name and address mentioned above. There after I called two disinterested witnesses from there namely (1) Prem Gour (32) s/o Shiv nath Gour of Hospital More PS Bagdogra Dist. Darjeeling and (2) Joynal Abedin (30) s/o Md Joynul of Halal Ps Bagdogra Dist. Darjeeling, in the very presence of the witnesses I searched and recovered the above mentioned liquors from the possession of the apprehended person and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 00-15 hrs and 00-45 hrs (seizure Total 12.6 Lts).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Pankaj Choudhury (22) s/o Bipul Choudhury of Barolaska PS Matigara Dist. Darjeeling and arrange for its investigation.
