Sir,

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one arrested accused person namely Basu Routh (20) s/o Lt. Kishor Routh of Khudirampally PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Twenty (20) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
2. Eight (8) sealed Bottles of Emboss Fine Whiskey, each bottle 750 ml each Marked as exhibit -B in which 01 bottle taken as sample for examination exhibit-B1.
3. One Nylon Bag which used to carry the Liquor noted in SL.No. 1 & 2.

I am submitting a written complaint against the above noted accused person to the effect that today 06.06.22 at 19-30 hrs received secrete source of information that one person was selling Liquor illegally at Bagdogra Station More to its customers without any valid license. Accordingly the duty officer of Bagdogra PS informed the matter to O.C. Bagdogra PS and as per his instruction myself along with QRT mobile van officer SI Mijanur Rahaman and force and C/1008 Kanak Roy, CV- 386 Kishor Hawlder CV- 389 Janak Singh, VP- 02 Pradip Roy left for Bagdogra Station More to verify the veracity of information which noted in GD vide Bagdogra PS GDE No. 335 dt. 06.06.22. On arrival at the spot at 19-55 hrs it was found that one person mention above was selling liquor illegally at Station More area to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I with the help of others police personnel searched and recovered 1. Twenty (20) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, 2. Eight (8) sealed Bottles of Emboss Fine Whiskey, each bottle 750 ml which was kept in a Nylon bag from the possession of the apprehended person and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 20-15 hrs and 20-55 hrs (seizure Total 18 Lts).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Basu Routh (20) s/o Lt. Kishor Routh of Khudirampally PS Bagdogra Dist. Darjeeling and arrange for its investigation.
