I, Nitashree Sen, daughter of Mr. Bikash Kumar Sinha, from Kishanganj, Bihar A/P Netaji Subhash Road, Subhash Pally, Ward No. 20, Siliguri (M. Corp), Darjeeling, Siliguri writing this letter in a very unfortunate and tough time. I would like to make a complaint against my husband and his family for provoking. I got married on 18.11.2010 with Abhijit Sen with family member named Achintya sen, (father in law) ,Aridam sen(brother in law), Subhra Sen (sister in law). After few days since marriage I was started assaulted by Subhra Sen (sister in law) & Achintya sen, (father in law) with my husband support to not carry my further studies and to contribute my full energy in doing daily domestic work & cooking only. As a wife, I carry all my responsibilities till date even I'm not good in physical state due to retina surgery problem. He often goes to work without any information and without giving me proper maintenance amount for livelihood for me and my child. He often comes at late night with an aggressive fighting mode. He is also an alcoholic person, starts drinking in front of child and always abuse about me and my maternal family members.

He has been beating me frequently since marriage. On dated 03.06.2022 approx. 1:30 p.m. he started beating me in front of my child and his family members. None of his family members has stood in my support, act as a bystander & when I urged to get me free to lodge police complain, he strangled my neck and tore my garments in front of everyone by saying I will strangle you today till my death. He has an intention to kill me so I left that house in traumatic condition after my parents from kishanganj approach siliguri approx. 9 P.M. I have left that house with my one cloth & my entire related things are there. Moreover in his every economic crisis moment, he always pressurized me to get help financially from my retired Ex- father and my working brother. Most of are in cash form but some transactions are in account also. Due to such kind of behavior, I start feeling mentally assaulted since few years.

After reaching kishanganj I have checked myself physically with doctor (Medical report attached). I came late to your thana because of my mental trauma & physical condition.

Finally, I came to a conclusion to kindly file a complaint against my husband named Abhijit sen and his family members Achintya sen, (father in law), Aridam sen(brother in law), Subhra Sen (sister in law) for provoking for domestic violence & abuse in form of physical and mental assault to me and force me to bring financial help from my maternal house. Please punish them accordingly.
