Sir,

With due regard and humble submission I Smt. Rina Kumari Wife of Sri Rajeev Kumar and daughter of Sri ShyamSundarRam , permanent resident of Damodar Colony, Pashchim Pally, Ondal , Barddhawan, WB, PIN- 713321 do hereby submit the following for your kind perusal and necessary legal action :-

1. That I was married on 11/12/2019 with Sri Rajeev Kumar S/o late Jay Narayan Prasad of ChampasariAnchal, Near Jay Guru School, P.O – Champasari, P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling according to Hindu rites and rituals/ customs at Hotel Vinayak Inn & restaurant, Pradhan Nagar, Siliguri, P.O & P.S- Pradhan nagar, Siliguri, Dist- Darjeeling and my father paid the entire expenditure of the said hotel & marriage .
2. That my father gave all things/ articles i.e. all kinds of furnitures, utensils & other things as per demand of the above named in-laws /persons and my father also gave Rs. 5,00,000/- in cash, one Diamond ring, and other gifts items as per demand by Rajeev Kumar (husband) and also demanded a Four Wheeler .
3. That after marriage Sri Rajeev Kumar took me to his house as above mentioned to lead conjugal life and I came to know that my husband Sri Rajeev Kumar is a Development Officer in LIC- Darjeeling.
4. That for two to four days everything was normal but after four days my sister in law namely Rinku Prasad started provoking the other in-laws against me and my mother in law took all my ornaments from me and kept in her custody and did not return till date.
5. That all the members of the family i.e. the in-laws above started to behave rudely/ cruelly with me and when I asked them about their rudeness/ cruelty, then they misbehaved and abuse me and my father in abusing language that my father have not provided them sufficient dowry as per their demand and they use to take work from me like a servant and did not allow me to take rest and torture me mentally & physically .
6. That when I informed the mater to my husband then he physical assault me and threaten that I shall have to obey their command otherwise he will leave me and with fear I use tolerated their illegal act & activities with a hope that they might change their rude behavior toward me but all in vain.
7. That during my stay for about one month at my husband's house, the illegal act & activities upon me by my husband and in-laws above named became more painful day by day and I use to tolerate the same with a hope that will realize their guilt .
8. That all the above name persons use to make conspiracy against me to drag me out of the house and to keep no relation with me and in the last week of January 2020 my father came to take me in ritual manner and my mother in law did not return back my ornaments & she retain the same for her ill motive.
9. That several times I and my parents informed/requested my husband and in-laws to take me back to lead conjugal life but they all avoided and they did not come to take me back from my parents' house and avoided me intentionally as my parents did not fulfill his desire of dowry.
10. That my father and mother came to Siliguri and requested Rajeev Kumar & his mother and other family members to take me back but they refused and they insulted my parents and told that they will not keep any kind of relation with me.
11. That a meeting was held by the relative and friends of Rajeev Kumar and my father was present and in the said meeting it was decided that Rejeev Kumar will return the entire goods/ articles whatsoever given in the marriage by my parents and the Cash amount of Rs. 7,00,000/- within one month.
12. That Rajeev Kumar only returned Rs, 2,00,000/- out of Rs. 7,00,000/- and kept all of us in dark and till date he did not return my goods/articles/ Diamond ring and cash amount till date and kept us dragging and making false statements.

13 That from sources I have come to know that Rajeev Kumar is going to marry again with one Rani Kumari D/O Sri Awadesh Prasad and the marriage is to be held on 08/06/2022 at Rishi Bhawan, Burdwan Road, Siliguri, Dist- Darjeeling as he had obtained a huge amount of Dowry from them to fulfill his illegal desire.

14 That Rajeev Kumar with the help of his other family members above named have ruined my life and they are again trying to spoil the life of another innocent girl by keeping the in dark.

15 That till today I am the legally married wife of Rajeev Kumar and he has not yet obtained any Divorce from me and he is marrying again during my life time in a illegal manner with the help of his family members by keeping everyone in dark of their ill motive & dowry.

16 That Rajeev Kumar and the in-law above named have threatened me that if I or any of my family members tries to lodge any kind of Complaint against them they will Kill me and my father as they have sources and contact with antisocial elements and do anything any time and in fear I am lodging this complaint for the illegal act and activities of the above named person who have ruined my life for want of dowry. And in the marriage card Rajeev Kumar has written his as Rajeev Prasad.

Under the above facts and circumstances you are requested to please help me and do the needful & take legal action against Rejeev Kumar and in-laws above named who have ruined my life for their greed of dowry and also trying to marrying another girl in an illegal manner without any fear and against the law and further request you to stop the marriage between Rajeev Kumar and Rani Kumari which is going to be held today on 08/6/22 at SHREE BHAWAN, Bardwan Road, Siliguri in an illegal manner, for which I shall be highly obliged.
