In producing herewith one accused person named Mantun Kumar Sharma (26) S/O- Mahendar Sharma of Govinpur ,P.S- Rosra, Dist – Samastipur , Bihar (not Verified) along with the following seized articles :-

1. 20 (twenty) bottles of McDowell's No-1 Superior Whisky each bottle containing 375 Ml. blended and bolted by Transways Exim PVT. LTD.

I, SI Atanu Mmajumdar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Mantun Kumar Sharma (26) S/O- Mahendar Sharma of Govinpur ,P.S- Rosra, Dist – Samastipur , Bihar (not Verified),to the effect that on 03/06/2022 at 14:45 hrs. In course of Van duty received a specific input from the source that the above noted person is selling illicit liquor roaming at Shalbari Bazar area to his design customers for his wrongful gain. Accordingly the fact is informed the fact to you. As per your direction I along with C/207 Niladri sarkar and CV-993 Anil Das as left for Shalbari Bazar area under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the said person noted above and detained him with a strong reason to believe that he has kept huge quantity of illegal liquor in his possession in bag. On searching found 20 (twenty) bottles of McDowell's No-1 Superior Whisky each bottle containing 375 Ml. blended and bolted by Transways Exim PVT. LTD. eeling . On being interrogation he could not produce any valid documents in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 05 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 15:45 hrs to 17:05 hrs. On being asked he stated that he kept the same with a view to sale and supply at Shalbari bazaar area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Person namely Mantun Kumar Sharma (26) S/O- Mahendar Sharma of Govinpur ,P.S- Rosra, Dist – Samastipur , Bihar (not Verified) , as per proper section of law and arrange it's for investigation .
