Sir,

In producing herewith one accused person named Tuntun Paswan, (30) S/O- Sri Ramadhar Paswan of Marsandi Matia P.S- Moti Pur Dist- Mujaffar Pur , Bihar A/P- Rajibnagar in the House of Mehadi Hussain P.S- Pradhannagar Dist- Darjeeling, , along with the following seized articles :-

1. 30 (thirty) plastic bottles of 70* UP Country spirit Kachi contains added flavor Mahua each bottle containing 300 Ml. manufactured by Prokash distillery , & Chemical Co(P) Ltd., Bandrijote P.S- Pradhannagar Dist- Darjeeling .

I, ASI Nilam Sarnakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Tuntun Paswan (30) S/O- Sri Ramadhar Paswan of Marsandi Matia P.S- Moti Pur Dist- Mujaffar Pur , Bihar A/P- Rajibnagar in the House of Mehadi Hussain P.S- Pradhannagar Dist- Darjeeling, to the effect that on 03/06/2022 at 16:55 hrs. In course of patrolling duty received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his grocery Shop ,situated at Panchanai near Bridge in order to sale the same to his design customers for his wrongful gain. Accordingly the fact is diarized vide Pradhannagar PS GDE NO-193 date 03/06/2022, and informed the fact to you. As per your direction I along with ASI Tarun kanti Ghosh , CV 223 Swapan Chettri and CV-128 Ajoy Sahani left for Panchanai near Bridge under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the Shop where he kept illicit liquor without any valid license and detained the above noted person with strong reason to believe that he has kept huge quantity of illegal liquor in his grocery Shop . On searching found 30 (thirty) plastic bottles of 70* UP Country spirit Kachi contains added flavor Mahua each bottle containing 300 Ml. manufactured by Prokash distillery , & Chemical Co(P) Ltd., Bandrijote P.S- Pradhannagar Dist- Darjeeling . On being interrogation he could not produce any valid documents in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 05 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19:05 hrs to 19:35 hrs. On being asked he stated that he kept the same with a view to sale and supply at Dagapur & Panchanai area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Person namely Tuntun Paswan, (30) S/O- Sri Ramadhar Paswan of Marsandi Matia P.S- Moti Pur Dist- Mujaffar Pur , Bihar A/P- Rajibnagar in the House of Mehadi Hussain P.S- Pradhannagar Dist- Darjeeling, as per proper section of law and arrange it's for investigation .
