In producing herewith one accused person named Birendra Sah (M/38), S/O- Chotelal Sah of Gandhinagar, PS Bhaktinagar, Dist Jalpaiguri under arrest along with following articles under proper seizure.

13 (Thirteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 7.8 liters)

I, SI Shibdhan Karmakar of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Birendra Sah (M/38), S/O- Chotelal Sah of Gandhinagar, PS Bhaktinagar, Dist Jalpaiguri to the effect that today on 05.06.2022 at while performing special van duty, received a source information that one person named Birendra Sah (M/38) without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with CV/646 Baban Das, CV/2242 Rakesh Mangar had been to Regulated Market, Gate No. 01 under Pradhan Nagar PS to verify the veracity of the information.

On reaching there and as identified by the source it was found that one person was selling and storing liquor at his shop named as Chotelal Hotel at Regulated Market, Gate No. 01 under Pradhan Nagar PS. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Birendra Sah (M/38), S/O- Chotelal Sah of Gandhinagar, PS Bhaktinagar, Dist Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:05 hrs to 20.25 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Birendra Sah (M/38), S/O- Chotelal Sah of Gandhinagar, PS Bhaktinagar, Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
