With due respect, I am producing herewith 04 (four) arrested accused persons namely (i) Rohan Rasaily (37 yrs) S/O Binod Rasaily of Gurung Busty, near Bir Jawan, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Sanjoy Subba (31 yrs) S/O Debendra Subba of Achanak Busty, Sukna, PS- Kurseong, Dist.- Darjeeling (iii) Akash Roy (26 yrs) S/O Bakul Roy of Promod Nagar, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and (iv) Sanjoy Singh (26 yrs) S/O Ajoy Singh of Debidanga, Cham'pasari, PS- Pradhan nagar, Dist.- Darjeeling and the following articles under seizure :-

- 1 One iron made sharp cutting weapon called as Bhojali recovered from the possession of accused Rohan Rasaily S/O Binod Rasaily of Gurung Busty, near Bir Jawan, PS- Pradhan Nagar, Dist.- Darjeeling.
- 2 One iron made sharp cutting weapon called as Bhojali and one torch light recovered from the possession of accused Sanjoy Subba S/O Debendra Subba of Achanak Busty, Sukna, PS- Kurseong, Dist.- Darjeeling.
- 3 One sharp cutting knife and one iron rod recovered from the possession of accused Akash Roy S/O Bakul Roy of Promod Nagar, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling.
- 4 One iron made sharp cutting weapon called as Hasua recovered from the possession of accused Sanjoy Singh S/O Ajoy Singh of Debidanga, Champasari, PS- Pradhan nagar, Dist.- Darjeeling.


I, SI Goutam Mallik of Matigara PS, Siliguri Police Commissionerate beg to state that on 09.06.22 at 01.15 hrs received a secret source information that that a gang of miscreants come at near Chandmoni ground under PS- Matigara, Dist.- Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Pati Colony area. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 515 dated 09.06.22 and informed the fact to you. As per your order I also informed the fact to Night RT Van officer SI Md Sanaula and requested him to come to near Chandmoni ground to accompany with us. At 01.45 hrs we arrived at near Chandmoni ground under PS- Matigara, Dist.- Darjeeling. After a few time RT Van officer SI Md Sanaula of Matigara PS along with force came to near Chandmoni ground and accompany with us. At about 02.05 hrs as indicated by the source we noticed that 08/10 persons assembled in a dark place near Chandmoni ground under PS- Matigara, Dist.- Darjeeling and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party managed to apprehended 04 (Four) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity in a house of Patiram Jote area. On search the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested above noted 04 (Four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made in between 02.55 hrs and 03.45 hrs on 09.06.22.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the above noted arrested accused persons namely (i) Rohan Rasaily (37 yrs) S/O Binod Rasaily of Gurung Busty, near Bir Jawan, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Sanjoy Subba (31 yrs) S/O Debendra Subba of Achanak Busty, Sukna, PS- Kurseong, Dist.- Darjeeling (iii) Akash Roy (26 yrs) S/O Bakul Roy of Promod Nagar, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and (iv) Sanjoy Singh (26 yrs) S/O Ajoy Singh of Debidanga, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and arrange for its investigation.


